#### I. Call to Order:

# III. Approval of Past Minutes:

President Armold presented the minutes of the regular meeting, held on Thursday, May 15th, 2025. Rayburn addressed the Commission, requesting to receive the previous meeting minutes prior to the meeting, noting a discrepancy which was found within page 2, section C of the minutes as presented. #### VII. Old Business

## A. Discussion of Comprehensive Plan Amendments

## a. Master Park Plan Update

BC Davis provided an update on the Master Park Plan timeline. A second committee meeting recently occurred, where survey results were reviewed with the public. A public meeting also took place, gathering significant resident input on desired park changes.

Upcoming steps include stakeholder meetings and the proposal of a draft plan for review by the end of next month. Following this, another committee meeting will be held before submitting the draft to the Indiana DNR for comments. Once comments are received, revisions will be made, and the final draft will be submitted for adoption into the Master Park Plan. This adoption will then allow it to be integrated into the Comprehensive Plan, making it eligible for future program funding grants.

### b. Housing Action Plan Final Draft

BC Davis presented the City of Rensselaer's Housing Action Plan. He plans to invite a representative from HWC to the next APC meeting to discuss the overall plan. Davis highlighted HWC's suggested changes to the Zoning and Subdivision Control Ordinances to promote housing development and noted that HWC also reviewed the current fee structure, with details still being finalized for the next APC meeting. He requested the PC review these documents for discussion at their next meeting.

### c. Future Land Use Map Review

The PC was presented with a copy of the City's Future Land Use Map, to which BC Davis explained a few changes which had been made, in alignment with suggestions made by HWC.

## B. Update on Prairie St Committee

BC Davis reported that the Plat Committee devised a plan, which Avery Walker intended to propose to Attorney Lori James. Lori James understood there was an initial proposal to equally divide Prairie Street between Schwab and Shultz, followed by a counter-proposal to Schwab, for

which an update is pending. Davis plans to meet with Avery to discuss further, aiming to resolve the matter before it goes to the Council.

### VII. Public Comments:
