ED DUMAS CAME TO THE PARK CORPORATION'S SPECIAL MEETING TO DISCUSS WITH PARK CORPORATION MEMBERS ON GETTING A PROFESSIONAL FUNDRAISER GROUP INTO RENSSELAER TO GUIDE US AND HELP RAISE MONEY FOR THE PARKS. ED TOLD PARK CORPORATION MEMBERS IF THEY AGREE ON USING A PROFESSIONAL FUNDRAISER GROUP THE BLACKER TRUST IS WILLING TO PAY FOR IT. A LENGHTY DISCUSSION FOLLOWED.
