# MINUTES OF THE REGULAR MEETING BOARD OF PUBLIC WORKS & SAFETY October 9, 2023

The minutes of the September 11, 2023 regular board meeting were presented and approved upon a motion by Wood, second by Odle, to approve the minutes as presented. The motion passed unanimously.

# New Main Lift Station & Unsewered Areas Project:

- **A.** Thieneman Pay Request #17: Lockridge said this \$125,737.60 pay request covers change order #5, a portion of change order #7 and work on the phosphorous building. There was a motion made by Odle, second by Watson, to approve pay request #17. The motion passed unanimously.
- **B.** Commonwealth Invoice: J. Lockridge said this invoice for \$2,382.48 covers additional construction, design work and resident project representative. There was a motion by Odle, second by Watson, to approve the invoice. The motion passed unanimously

### Waterworks Improvements Project:

#### **Division A (Elevated Water Storage Tank)**

A. Maguire Iron Pay Request #4: J. Lockridge said this pay request for \$61,750.00 brings the contract to 50% complete. Pieces of the tower are being brought to the site to begin assembly. There was a motion made by Wood, second by Odle, to approve pay request #4 (SRF #21). The motion passed unanimously.

# Division B (Water Main and Water Service Replacement)

A. Grimmer Construction Pay Request #3: Lockridge said this pay request for \$382,939.00 covers work on Weston St. and service lines on Van Rensselaer St. The contract is at 40% completion. Odle asked if the work would be done by the end of the year. Lockridge said they hope to be done by December. There was a motion made by Wood, second by Watson, to approve pay request #3 (SRF #20). The motion passed unanimously.

**Firefighter Promotion Request:** Haun said he would like to promote this current firefighter from intern to probation. He will be enrolled in training in November. There was a motion by Wood, second by Watson, to approve the promotion. The motion passed unanimously.

There being nothing more to come before the board, there was a motion by Odle, second by Watson, to adjourn. The motion passed unanimously, and the meeting adjourned at 5:38 p.m.
