BRANDON SCHREEG WITH REMENSCHIEDER ASSOCIATES CAME TO THE PARK CORPORATION'S SPECIAL MEETING
TO PRESENT HIS CONCEPT PLAN FOR THE STADDON FIELD / MONNETT SCHOOL PROPERTY. BRANDON WENT THROUGH HIS
PLAN WITH PARK CORPORATION MEMBERS AND WAS LOOKING FOR FEEDBACK FROM THEM. THE MEMBERS IN
ATTENDANCE LIKED THE PLAN BUT WANTED THE OTHER 4 BOARD MEMBERS WHO COULD NOT ATTEND THE MEETING TO
GET TO REVIEW THE PLAN AND MAKE COMMENTS OR ASK QUESTIONS. KRISTEN ZIESE SUGGESTED TO SENT THE MEMBERS
